

Privacy policy Use of Websites and Webshops Best Fresh Group

We recognise that you place your trust in us. We therefore see it as our responsibility to protect your privacy. Our use of collected data:

Use of our services

When you register for one of our services, we ask you to provide personal data. This data is used to perform the service. The data is stored on secure private servers of BFG or those of a third party.

Communication

When you send us email or other messages, we may keep those messages. Sometimes we ask you for your personal information that is relevant to the situation in question. This makes it possible to process your questions and answer your requests. The data is stored on secure private servers of BFG or those of a third party.

Cookies

We collect data for research in order to gain a better understanding of our customers so that we can tailor our services to them.

This website uses "cookies" (text files placed on your computer) to help the website analyse how users use the site. The information generated by the cookie about your use of the website can be transferred to secure private servers of BFG or to those of a third party. We use this information for the purpose of tracking your use of the website, compiling reports on website activity and providing other services relating to website activity and Internet usage.

Purposes

We do not collect or use information for purposes other than those described above unless we have obtained your prior consent to do so.

Third parties

The information is not shared with third parties, with the exception of web applications that we use for our webshops. This data will only be used for the purpose of the application in question and will not be further disseminated. In some cases, the information can also be shared internally. Our employees ensure that the confidentiality of your data is respected.

Security and retention

The organisation takes appropriate measures to prevent misuse, loss, unauthorised access and other undesirable actions involving personal data.

The personal data collected will not be kept longer than necessary.

This privacy statement is tailored to the use of and the possibilities on this website. Any changes to this website may lead to changes in this privacy policy. It is therefore advisable to consult this privacy policy on a regular basis.
